RULES AND REGULATIONS

NO PURCHASE NECESSARY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES.

(1) **CONTEST PERIOD:** The Contest begins at **4:30PM** (Toronto time) on **Wednesday, February 22** and ends at **5:30PM** (Toronto time), on **Wednesday, February 22** (the "**Contest Closing Date**").

(2) **ELIGIBILITY:** The Contest is only open to legal residents of Canada, who are 19 years of age or older. Employees, their immediate families (and those with whom they are domiciled) of Maple Leaf Sports & Entertainment Ltd. ("MLSE"), the MLSE Team Up Foundation, Rogers Wireless Partnership ("**Rogers**") (collectively the "**Contest Sponsors**") and their respective parents, governors, subsidiaries, affiliates, directors, officers, shareholders and agents (collectively the "**Released Parties**") are not eligible to enter.

(3) **HOW TO ENTER: No Purchase Necessary.** To enter the Contest you must: (i) be a follower of @TeamUpFndn on Twitter; and (ii) use the #PlayersGala hashtag in your tweets; and (iii) answer a trivia question correctly during the Twitter chat taking place on Wednesday, February 22 ("**Contest Date**"). Maximum of 1 entry per person. All entries must be submitted from a valid Twitter account. Potential winners may be requested to provide MLSE with proof that the potential winner is the authorized account holder of the Twitter account associated with the winning entry. By entering the Contest, you agree to be bound by the Contest Rules and the decisions of Contest Sponsors, which are final with respect to all matters relating to the Contest.

Attempts will be made by MLSE to contact the selected entrant by Direct Messaging through Twitter, email or via phone. At such time the selected entrant will be required to provide MLSE with the contact information requested by MLSE (e.g. full name, age, telephone address, e-mail address and confirm his/her eligibility. If the selected entrant does not meet all of the Contest conditions, refuses to provide the contact information requested, or contact cannot be made within twenty-four (24) hours after MLSE's first attempt at contact, that entry will be disqualified and MLSE shall be entitled to select another eligible entrant. This process may continue until the prize has been awarded or there is insufficient time to permit the awarding of the prize. MLSE is not responsible, whether as a result of human error or otherwise, for any failure to contact any potential winner.
